**“Resolution of the Board of Fire Commissioners of Fire District No. 1,
Township of Bordentown, County of Burlington, State of New Jersey
to Engage the Division of Local Government Services within the Department of Community
Affairs to Begin Preliminary Discussions Regarding Fire District Consolidation”**

WHEREAS, the Board of Fire Commissioners of Fire District No.1 is responsible for providing fire protection services to the residents of the district; and

WHEREAS, the Board of Fire Commissioners of Fire District No.1 has contacted the Division of Local Government Services within the Department of Community Affairs to obtain general technical guidance on the processes and resources available for Municipalities exploring shared services or consolidation; and

WHEREAS, the Board has determined that it is in the best interests of the residents of Fire District No.1 to explore and develop a consolidation plan with Board of Fire Commissioners of Bordentown Township Fire District No.2 of the Township of Bordentown, County of Burlington, State of New Jersey; and

WHEREAS, N.J.S.A. 40A:14-90.2 authorizes a Municipal Governing body to consider consolidation upon receipt of parallel resolutions from the Boards of Fire Commissioners; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No.1 hereby requests and consents to work with the Division of Local Government Services within the Department of Community Affairs to begin preliminary and transparent discussions regarding the potential benefits of Fire District consolidation; and

BE IT FURTHER RESOLVED THAT, the foregoing is a true and correct copy of a Resolution approved and adopted by the Board of Fire Commissioners of Fire District No.1 of the Township of Bordentown on this 5th day of February, 2026.
